

## Conditions and Terms of Sale and Delivery

### 1. Aim and subject

This General Conditions and Terms of Sale and Delivery (hereinafter referred to as 'GTD') has been issued by ATTROY Kft., a Supplier engaged in service activities, with the purpose of establishing a standard form as regards the conditions of continuous cooperation between itself and its Customers.

### 2. Prices

- 2.1. Prices shall always be determined on the price-lists of web shops. Supplier's price-lists shall always be valid together with Supplier's remarks indicated on the price-lists in question.

### 3. Orders, confirmation

- 3.1. Buyer's orders placed during the pre-order period, confirmed with voucher.

### 4. Delivery deadline

- 4.1. Delivery deadline shall bind Supplier to effectuate delivery in conformity with festival periods stipulated in the accepted confirmation of the order.

### 5. Service conditions

- 5.1. Tent package owners are free to take their tent anywhere inside and outside of the Island. The 2 person pop up tent and the deluxe tent is a fast tent, which are easily to put up, but should be fixed by the ropes included in the package. BE AWARE that these tents are **limited water proof**, so in case of heavy rain interior might get wet. We can not guaranty dry tents, so if this case happen, please immediately return the tent, and we replace your tent to a dry one. **We accept complains only 24 hours after the rain.**
- 5.2. The polifoam included in the package is minimum 1,5 cm thick and size 180 X 110 cm, which should be placed under the tent. In case of deluxe set, airbad should be put inside, we provide help to inflate airbed. The polar blankets are standard size.
- 5.3. ATTROY service buys back the package (minimum polifoam and tent in any condition should be returned) at 20 EUR price, in deluxe package (airbed + tent) 30 EUR paid in cash upon receivment at the end of the festival.
- 5.4. The tents are given to charities by Sziget later on.
- 5.5. Tents are festival tents **limited waterproof**, it should not be leaking in a normal summer rain. In case of any complaint ATTROY exchange tents free of charge on spot. Please do not wait until your belongings get wet. Please place your valuable things in the lockers, and your luggage at the luggage store area.

### 6. Payment

6. Payment shall be deemed fulfilled if Supplier's bank account has been credited with the sum (indicated on the invoice) or the sum has been paid through Festival.Travel, Sziget Festival webshops, other official Sziget Festival retailers.

### 7. Warranty

- 7.1. Parties agree to exercise the warranty rights and their obligations as regards of law. In case of any storm exceed normal level of rain, provider handles it as vis major, so not liable for flood, but provides dry used exchange tents.

## CLOSING PROVISIONS

This GTD shall constitute a compete agreement between the parties, furthermore it shall supersede all previous agreements concluded either in writing or verbally or all other actions taken between the parties referring to the subject of this agreement prior to Cutomer's first accepting this GTD.
