

Sziget Festival 'Budapest' promotion game – Rules of Participation

This present Rules of Participation (hereinafter the Rules) set forth the terms of participation in the promotional prize game "Budapest" (hereinafter the Prize Game) to be held in connection with Sziget Festival 2017.

Organizer of the Prize Game. The Prize Game is organized by the organizer of Sziget Festival 2017, Sziget Kulturális Menedzser Iroda Korlátolt Felelősségű Társaság (Hajógyárisziget, hrsz. 23796/58, 1033 Budapest, Hungary, reg. No. 01-09-263756, tax number: 10837410-2-41, hereinafter Sziget).

Term of the Prize Game. The Prize Game shall be held between 12 noon, May 18, 2017 and 12 noon, June 12, 2017 (CET).

Description of the Prize Game. All persons purchasing a 7-day pass for Sziget 2017 according to these Rules during the term of the Prize Game shall automatically participate in a Prize Draw.

The Prizes are the following:

- 25*2, so altogether 50, Sziget-Budapest Citypass (Gift 1) shall be selected by draw among the participants.
- 25*2, so altogether 50, Sziget Boat Party tickets (Gift 2) shall be selected by draw among the participants.
- 25*2, so altogether 50, Budapest Eye- Ferris wheel tickets (Gift 3) shall be selected by draw among the participants.
- 25*2, so altogether 50, Hop-on Hop-off Sightseeing tickets (Gift 4) shall be selected by draw among the participants.
- 25*2, so altogether 50, Budapest Walking Tour tickets (Gift 5) shall be selected by draw among the participants.
- 25*2, so altogether 50, Cocktails at the 360 Bar (Gift 6) shall be selected by draw among the participants.
- 25*2, so altogether 50, Lupa Beach entry tickets (Gift 7) shall be selected by draw among the participants.
- 25*2, so altogether 50, Sziget Payment bracelets (Gift 8) shall be selected by draw among the participants.

The Main Prize:

- Flexotel accommodation at the festival for 2 person (double room with box spring beds, towel, bed linen, table with two chairs, storage space for clothes, power supply, light, lockable room)
- Exclusive backstage tour with organizer of the festival
- Selfie from the Dan Panaitescu Main Stage
- Exclusive supply to all accessories for Special parties (all 7 days) for 2 person

Participants. All natural persons shall automatically participate in the Prize Game who purchase, during the term of the Prize Game, a 7-day pass for Sziget Festival 2017. Only such a transaction shall be considered as a purchase which is closed by a payment transaction.

Procedural Rules. The Term of the Prize Game shall be divided into five equal, five-day rounds. A prize draw shall take place following each of these rounds. The prize draw shall be made mechanically and in a way that in each draw, forty purchasers shall be selected randomly (that is a total number of five times forty purchasers, hereinafter collectively referred to as the Winners.)

The five rounds of the Prize Game and the draws:

1st Round: 7-day purchases made between 12 (noon) May 18 – 12 (noon) May 23. Announced at 7 pm (CET), May 25.

2nd Round: 7-day purchases made between 12 (noon) May 23 – 12 (noon) May 28. Announced at 7 pm (CET), May 30.

3rd Round: 7-day purchases made between 12 (noon) May 28 – 12 (noon) June 2. Announced at 7 pm (CET), June 4.

4th Round: 7-day purchases made between 12 (noon) June 2 – 12 (noon) June 7. Announced at 7 pm (CET), June 9.

5th Round: 7-day purchases made between 12 (noon) June 7 – 12 (noon) June 12. Announced at 7 pm (CET), June 13.

Draw for the Main Prize shall be made and the winner shall be announced at 8 pm (CET), June 13. The participants of the Main Prize draw shall be the Winners of the previous rounds of the Prize Game.

Winners shall be announced at the time indicated above on the online platforms of Sziget Festival (official website and official Facebook page). The exact number of prizes is connected to the purchaser and not to the number of passes purchased, therefore each Winner shall be entitled to the winnings regardless of the number of passes they had purchased. The Winners shall also be directly notified about their being selected by Sziget within fifteen days from the draw.

Legal Characteristics of the Prize Game. The Prize Game shall be considered as a prize game not classified as a gift draw. Sziget shall pay all taxes after the winnings. The Winner shall be obliged to cooperate with Sziget and assist Sziget in fulfilling its tax obligations by providing, until June 30, 2017, their personal data, as requested by Sziget, which shall be the condition of their receiving the prizes. If a given Winner fails to communicate his/her personal data requested by Sziget within this deadline, then he/she shall forfeit his/her winnings.

General provisions. The Prize Game shall be held pursuant to these Rules. These rules are accessible via <http://en.szigetfestival.com/policy-gctc>, and Sziget shall secure their continuous availability until August 31, 2017. Participants shall accept these Rules as binding by purchasing 7-day pass during the term of the Prize Game. Participants shall be entitled to refuse the receipt of the Gifts or the Main Prize. The name of the Winners shall only be published on the online platforms of Sziget (Sziget Festival official website and official Facebook page).
