

**PRIVACY NOTICE CONCERNING THE PROCESSING OF PERSONAL DATA  
PROVIDED IN CONTRACTS**

We process the personal data of the Partner’s contact persons provided while making a bid or entering into a contract with Sziget Cultural Management Ltd. or in the contracts concluded with Sziget Cultural Management Ltd. and the personal data provided in connection with the Art of Freedom tender in accordance with Regulation (EU) 2016/679 of the European Parliament and of the Council (hereinafter: “**GDPR**”) as well as Act CXII of 2011 on Informational Self-Determination and Freedom of Information.

<b>Purpose of processing</b>	Keeping contact while making a bid, entering into a contract or fulfillment of a contract, exercise rights and perform obligations deriving from the contract. Furthermore, the name, telephone number and address of the contact persons designated in the agreement on commercial activities are processed in order to secure that the POS terminals provided by the Controller’s partner, FestiPay Zrt., are delivered to the persons entitled to receive them, to prevent the

	<p>misuses of them. In case of the name of the creators designated in the Art of Freedom tender, the further purpose of the processing is the evaluation of the tender and the identification of the rightsholders of copyright.</p>
<b>Duration of processing</b>	<p>The Controller deletes the personal data after 5 years following the failure of entering a contract or the termination of a contract except for a legal dispute, in an event of which, the personal data will be deleted after the final end of the legal dispute or the enforcement proceedings.</p>
<b>Legal basis for processing</b>	<p>Legitimate interest of the Controller pursuant to Article 6 (1) f) of the GDPR.</p> <p>The legitimate interest of the Controller is to keep contact during entering into and performing the contract and to exercise rights, perform obligations deriving from the contract, furthermore, in case of the Art of Freedom tender, the evaluation of the tender and the identification of the rightsholders of copyright.</p>
<b>Transfer</b>	
<p>Personal data are processed by the employees of the Controller in order to achieve the abovementioned purpose.</p> <p>The name, telephone number and address of the contact persons designated in the agreement on commercial activities are transferred to FestiPay Zrt.</p> <p>In case of the Art of Freedom tender and the open call for Living Statute Championship it is necessary to implement a questionnaire application, in which the name of the creators/performers, e-mail address, telephone number and photo as personal data is being processed; to carry out this, the Controller applies the following entity: TYPEFORM SL (Carrer Bac de Roda, 163, local, 08018 - Barcelona, Spanish tax number: B65831836, e-mail: <a href="mailto:support@typeform.com">support@typeform.com</a>). In connection with contracts to be concluded with exhibitors at the Gourmet Festival, it is necessary to use a questionnaire application, in which the name of the person authorized to sign on behalf of the exhibitor, the name of the exhibitor's contact person, telephone number, and email address, as well as the name of the exhibitor's professional contact person (chef) are being processed as personal data, for which the Controller also uses the services of TYPEFORM SL.</p> <p>Further to these, TYPEFORM SL shall be a separate data controller, you may reach its privacy policy via this link: <a href="https://admin.typeform.com/to/dwk6gt/">https://admin.typeform.com/to/dwk6gt/</a></p> <p>Otherwise, no personal data will be transferred to third countries or to international organisations.</p>	
<b>Rights, legal remedies, complaints</b>	
<p>Pursuant to the GDPR, during the data processing, you may request access to the personal</p>	

data and may request information about data processing (which will be provided by the Controller within no more than 1 month), may request rectification of personal data or the restriction of data processing, and you have the right to object.
