

## **Sziget Festival Pre-registration Terms and Conditions ("Supplemented Terms and Conditions")**

**Sziget Cultural Management Limited** (registered seat: 1033 Budapest, Hajógyári sziget 23796/58., company registration number: Cg. 01-10-049598, hereinafter "**Sziget**"), on basis of the previously determined terms and conditions (hereinafter "**Former Terms and Conditions**"), has offered pre-registration (hereinafter "**Pre-registration**") for the **2026 Sziget Festival** (hereinafter "**Event**"), which allows persons over 16 (sixteen) years of age completing the pre-registration (hereinafter "**Participants**") to purchase a **Full Festival Pass, Full Festival VIP Pass, or 21&Under Full Festival Pass** (hereinafter collectively "**Pass**" or "**Passes**") for the Event during the first sale of Passes (hereinafter "**'Super Early Bird by Revolut' First Sale**") at the best price (hereinafter "**Best Price**") available from Sziget for 48 hours reckoned from the Start of the First Sale. With regards to the high level of interest, Sziget supplements the Former Terms and Conditions and, in accordance with the present Supplemented Terms and Conditions, makes the passes available up to the amount of the sellable passes in accordance with the capacity of the Event provided that the Pre-registration and the related *'Super Early Bird by Revolut' First Sale* shall be governed uniformly by these Supplemented Terms and Conditions.

Pre-registration can be completed by providing an email address during the Pre-registration period. By completing the Pre-registration, Participants accept these Supplemented Terms and Conditions and the privacy policy related to Pre-registration. The declaration of acceptance made in relation to the Former Terms and Conditions shall hereinafter be deemed to constitute acceptance of these Supplemented Terms and Conditions, with the proviso that the privacy policy relating to the Former Terms and Conditions shall also apply mutatis mutandis to these Supplemented Terms and Conditions.

Pre-registration does not create any obligation to purchase, but Passes at the Best Price are only available to Participants, i.e. persons who have completed Pre-registration.

The Pre-registration period ends 48 (forty-eight) hours prior the start of the *'Super Early Bird by Revolut' First Sale*. Sziget shall publish the date of the end of the pre-registration period and the start and end of the *'Super Early Bird by Revolut' First Sale* and may also inform the Participants separately.

During the *'Super Early Bird by Revolut' First Sale*, each Participant is entitled to purchase at the Best Price once. The number of Passes that can be purchased per transaction is maximum 4 (four) of each type. The Best Price cannot be combined with any other discount.

During the *'Super Early Bird by Revolut' First Sale*, Sziget will verify Participants based on the email address provided during Pre-Registration. Sziget excludes any liability for any misuse related to the Pre-registration or the *'Super Early Bird by Revolut' First Sale*.

During the *'Super Early Bird by Revolut' First Sale*, Sziget's relevant terms and conditions shall apply to any other issues.
