(hereinafter: "Festival" or "Event") involves you, we process various personal data in connection with it that we process in accordance with the relevant effective legislation, especially Regulation 2016/679 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (hereinafter the "GDPR"). We hereby inform you on the details of the processing of your personal data and your corresponding rights.

DATA PROCESSING RELATED TO NEWSLETTERS

Sziget Zrt. provides information on several channels to those interested in its Events; thus, it sends newsletters to subscribers thereto. The newsletters are not the same as the servicing mails sent to the person buying a ticket for the Event.

In connection with newsletters, we process data in accordance with Act CXII of 2011 on Informational Self-determination and Freedom of Information (hereinafter "Infotv."), the Regulation on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and the 2016/679 general data protection regulation of European Parliament and Council (EU) repealing Directive 95/46/EC (hereinafter "GDPR"), Act CVIII of 2001 on certain issues of electronic commerce services and information society services (Hereinafter "Eker. tv."), as well as Act XLVIII of 2008 on the Basic Requirements and Certain Restrictions of Commercial Advertising Activities (hereinafter "Grt.").

1.1. subscription to newsletters

The subscription is related to a specific Festival; therefore, the newsletters are in connection with the Event itself, or the general operation of Sziget Zrt. In certain cases, the newsletters contain the advertisements of third parties, too.

1.2. dispatching newsletters

During the registration for the newsletters – after becoming familiar with the preliminary notification by Sziget Zrt. –, you consent and accept that Sziget Zrt. tracks the activity (e.g. opening, clicking) in the newsletters sent to the registered e-mail address, as well as your purchases with the same e-mail address, and to use the data in order to display personalised advertisement that may contain third party ads as well on its own or a partner's side.

During the registration for newsletters, you also consent to that Sziget Zrt. sends or displays personalised advertisement that may contain third party ads as well based on the scope of the products and services concerning or connected to the current Event purchased with the identical e-mail address.

Profiling means any form of automated processing of personal data consisting of the use of personal data to evaluate, analyse or predict certain personal aspects relating to a natural person (e.g. personal preferences, interests, health status, behaviour, location or movements). Sziget Zrt. performs proofing in case of giving data non-mandatory for dispatching newsletters upon or

after the subscription to the newsletter based on consent in order to provide offers adequate to the needs, wishes, interests and purchased products and services. Such offers are also sent via newsletter, in e-mail.

DATA PROCESSING OF THE GAMES RELATED TO THE EVENT

Sziget Zrt. offers various games ("Games") on several channels in connection with its Events to those interested in them. In case the Game is organised as a prize game, data may be processed during the selection of the winner and the handover, provision of the prize for the winner, as well as the related correspondence. In case the Game is organised as a competition game, the winner is selected by some kind of jury typically based on subjective aspects, then receives an award. In case the Game is organised as a challenge, all participants who satisfy the requirements shall be eligible to the reward written in the challenge call. In case Sziget Zrt. announces some kind of a promotion, the privacy notice related to purchases shall be adequately applied. In case subscription to newsletters is also possible during a Game or a promotion, the related data processing shall be governed by the privacy policy related to newsletters. In case any game is not organised by Sziget Zrt. but a third party on its behalf or by a partner, the game call, the participation conditions and mode of data processing shall be determined, published by this third party, thus, the data processing is performed by such third party.

We present the general rules applicable to data processing occurring during Games. At certain Games, however, the scope of data, the data processing processes, storage periods and/or the addressees may be different, of which we shall inform the possible participants preliminarily in the Game call.

2.1. selecting the winners during the Game

From time to time, Sziget Zrt. calls for prize games or competition games, whereby it publishes in each case the exact participation conditions of the respective Game, the mode of selecting the winners of the prize (typically via machine draw) or the aspects of selecting the winners at the competition, the relevant deadlines. The exact scope of the data processed during the respective Game shall in each case cover the data in the Game call.

On the social media site, deletion may be done as the social media platform makes it possible. In case during the handover, using the prize/award photographs, audiovisual, creative materials are made, they may also be used by Sziget Zrt. for marketing purposes. Sziget Zrt. processes the photographic and audio recordings (hereinafter "Recordings") and the data therein for the purpose of creating from them (i.e. from the Recordings) audiovisual material aiming to present, publicize, and promote the use thereof the individual Events and the Events in total, as well as the Events, other services of, and Sziget Zrt. itself, furthermore, aiming at information and documentary purposes (together "Films"). The personal data contained in the Recordings are only processed in the context of making and publishing the Films as specified in the relevant data privacy policy. The Recordings, and, therefore, also the personal data included therein is processed by Sziget Zrt. for an indefinite period, however, acts as described above during the exploitation thereof. The Recordings, the Films, and the creations, creatives as a result of their exploitation are at the same time copyrighted works, with regards to their protection, Sziget Zrt. may not exercise deletion without the consent of the author but, upon the request of the data subject, in connection with the exploitation, the right of protest of the data subject can be exercise within the frameworks of technics and reasonable realisation (for which, please, contact us on the dpo@sziget.hu address). in case of a Game organised on a social media site: the operator of the Addressees social media platform (see Chapter 3) in case of a game granting tickets, discounts: Netpositive (database

As the operator of the page registered on the social media platform, Sziget Zrt. sees all the data of followers and commentators that such persons disclose, have disclosed (such as the username on the social media platform, photographs, information made public, comments).

The deletion and rectification of the data is possible based on the policies published by the operators of each platform, social networking, Sziget Zrt. is unable to do it.

The operators of each platform, social networking site are, based on the policies published by them, entitled to moderate the content that does not comply with the policy.

Data security

Sziget Zrt. shall ensure the security of the personal data and shall implement appropriate technical and organizational measures to ensure that the collected, stored and processed data are protected, in addition to preventing destruction, unauthorized use, and unauthorized alteration of the data. Sziget Zrt. shall furthermore notify third parties - to whom the data subject's information is transferred - that they are obligated to meet the data security requirements.

Sziget Zrt. shall ensure the prevention of unauthorized access to personal data, as well as the publication, transfer modification or erasure thereof.

Sziget Zrt. shall impose the aforementioned obligation onto its employees taking part in the data processing, as well as the data processors acting under the authority of Sziget Zrt.

The rights and legal remedies, complaints of data subjects

Pursuant to the GDPR, during the data processing, you may request access to the personal data and may request information about data processing (which shall be provided by Sziget Zrt. within no more than 1 month), may request rectification of personal data, erasure under certain conditions, or the restriction of data processing, and - when the legal basis for data processing is performance of a contract - you have the right to data portability. When the legal basis for data processing is legal interest, you have the right to object.

You can read further information about the rights in the *General privacy regulation* under the *Festival policy and general terms* menu of the websites.

If you feel that Sziget Zrt. has violated any of the legal provisions applicable to the data processing, please, contact us first, using any of the above contact information, or at the following email address: dpo@sziget.hu. If this proves to be unsuccessful, you may initiate a proceeding of the Hungarian National Authority for Data Protection and Freedom of Information (Nemzeti Adatvédelmi és Információszabadság Hatóság, NAIH, seat: Hungary, H-1055 Budapest, Falk Miksa utca 9-11.; mailing address: 1374 Budapest, Pf. 603.; email: ugyfelszolgalat@naih.hu) or seek judicial remedy.

Personal data related to children and third persons

Persons under 16 may not submit their personal data, except if they have requested permission from the person exercising parental rights. By providing your personal data to Sziget Zrt., you

hereby represent and warrant that you act according to the aforementioned, and your legal capacity is not restricted with regards to the providing of data.

If you do not have the right to independently provide personal data, you shall acquire the permission of the appropriate third party (i.e. legal representative, guardian, other person – for instance consumer - you are representing) or provide another form of a legal basis to do so. In relation to this, you shall be able to consider whether the personal data to be provided requires the consent of a third party. It may happen that Sziget Zrt. does not get into contact with the data subject, therefore, you are responsible for meeting all the necessary requirements and Sziget Zrt. shall not be liable or bear any responsibility in this regard. Nevertheless, Sziget Zrt. has the right to check and verify whether the proper legal basis is provided for the handling of data at all times. For example, if you are representing a third party – for instance a consumer – we reserve the right to request the proper authorization and/or consent of the party being represented with relation to the matter at hand.

Sziget Zrt. shall do its utmost to remove all personal information provided without authorization. Sziget Zrt. shall ensure that if Sziget Zrt. becomes aware of this, such personal information is not forwarded to any third party or used for Sziget Zrt.'s own purposes. We request that you inform us immediately via our aforementioned contacts if you become aware that a child has provided any personal data about himself or herself, or any other third party has provided any personal data of you unauthorized to Sziget Zrt.

Miscellaneous

This Privacy Policy was written in Hungarian, although its English version is also accessible. In the event of contradiction between the Hungarian and the English version, the Hungarian language version shall prevail.
