SZIGET 3-DAY PASS PRIZE GAME RULES OF PARTICIPATION

These present Rules of Participation (hereinafter: "**Rules**") set forth the terms of participation in the and prize game (hereinafter "Game") to be held under the name "Sziget 3-Day Pass **Prize Game**".

Organiser of the Game. The Game is organised by **Sziget Cultural Management Ltd.**, (1033 Budapest, Hajógyári sziget, hrsz. 23796/58., Hungary; tax number: 26189905-2-41; registration number: 01 10-049598, hereinafter "**Organiser**") organizing Sziget Festival 2025 (hereinafter "**Event**").

The term of the Game. The Game shall be held between 12:00, December 16, 2024, and 12:00, December 17, 2024 (CET). The Organiser reserves the right to change the term of the Game.

Participants of the Game. Any individual over 18 years old, having full legal capacity, may participate in the Game who, during the term of the Game, completes the task determined by the Organiser (hereinafter each a "**Player**", together "**Players**"). Taking part in the Game is considered to be an acceptance of these Rules and acknowledgement of the contents hereof as legally binding.

The proprietors and executive officers of the Organiser and other contributors having a role in carrying out the Game, their employees, agents, and their close relatives (Ptk. 8:1 (1)) may not participate in the Game as Players.

Description of the Game. The Organiser notifies the Players on the Game on the Facebook and Instagram site of the Event and by newsletter. The task of the Players is to tag, in a comment added to the Facebook or Instagram post, 2 (two) friends of theirs whom with they would happy to go the Event and to follow the Facebook or Instagram platform of the Event whereto the comment has been added by the Player. The Player may tag only 2 (two) person in the comment, however, the Player may publish more than 1 (one) comment with the condition that different persons must be tagged in each comment.

Among the Players, 1 (one) winner (hereinafter "**Winner**") will be chosen by draw. The prize of the Winner is 3 (three) pieces of 3-Day Pass for the Event (hereinafter "**Prize**").

The Player shall obtain the necessary permission and consent for tagging the third person in the comment and the related data processing. In case of tagging a third person, it shall be deemed that the Player has obtained any and all permission and consent necessary for the presentation and any data processing connected thereto. The Organiser's liablity is excluded in this regard.

The Organiser hereby notes that if the comment published by the Player or any element thereof contains a violent, obscene, pornographic or sexual, religious, political, hatred-inciting or otherwise offensive element, is offensive to others on the basis of ethnicity, religion, nationality, gender, political or other identity or in any way, violates the personal or intellectual property rights of others, or is inappropriate in the Organiser's subjective judgement, it will be disqualified from the Game by the Organiser. **Draw of the Winner, receiving the Prize.** The Organiser will select, through random drawing, the Winner among the Players and 3 (three) additional winners (hereinafter "**Additional Winner 1**", "**Additional Winner 2**" and "**Additional Winner 3**", together "**Additional Winners**"), on December 17, 2024. The Prize may not be exchanged for money. Neither the Winner, nor others are entitled to demand from the Organiser to exchange the Prize to money or to any other gift. The Organiser does not provide any other gifts or prizes in the Game other that is determined. No additional Winner will be selected if the Winner loses his or her right to receive the Prize or does not fulfil his or her obligation in the given term to get the Prize, or he or she refuses to get the Prize, Additional Winner 2, Additional Winner 2, or Additional Winner 3, in this order, will be entitled to receive the Prize.

The Winner will be notified on the Prize by Organiser via Instagram or Facebook message depending on which platform has been the winning comment published. The condition of delivery of the Prize is the provision by the Winner to Organiser the personal data (name, email address and such 2 [two] person's name and email address with whom the Winner uses the Prize) necessary for handing over the Prize within 15 (fifteen) days after being notified via Instagram or Facebook message. If the Winner fails to fulfil this obligation within the aforementioned time, he or she loses his or her right to receive the Prize.

The Prize will be delivered on 1 (one) occasion. By delivering the Prize, the Organiser verifies the entitlement for the Prize on basis of the name and e-mail address given by the Winner and such 2 (two) persons' name and e-mail address whom with the Winner uses the Prize, presented by the Winner. The Organiser expressively excludes its liability connected with the eventual abuses related to the receipt and use of the Prize.

Legal characteristics of the Game. The Game shall be deemed as a prize draw not qualifying as a gift draw. The Organiser undertakes to pay the personal income tax directly applicable to the Prize and the amount of any additional tax or other contributions directly related to the Prize.

General provisions. The implementation of the Game and the participation therein shall be in accordance with these Rules. The Organser excludes any liability arisen out of any abuse.

Liability matters. If there is an abuse or any suspicion of abuse during the time of the Game, the Organiser reserves the right to suspend or to terminate the Game or to exclude the offender from the Game. In such a case, the Organiser excludes its all liability.

The Winner bear all consequences of giving incorrect personal data or if his/her mailbox cannot receive letters. The Organiser is not able to check the correctness of the aforementioned personal data. In this regard the Winner shall exclusively bear all responsibility and all legal and financial consequences.

The Organiser excludes any liability for any demand for compensation or indemnification or for any cost, damage, loss incurred by the Players as a result of participating in the Game. By participating in the Game, the Player expressly waives his or her right to have any demand relating to conducting the Game, the Prize, the Winner, the Organiser or any other third parties.

The Organiser excludes its liability for any copyright infringement.

The Organiser shall not bear any liability if the webpage that contains these Rules periodically cannot be found due to technical reasons during the term of the Game. The Organiser shall not be liable for problems with the webpage and for their consequences beyond its control (for example technical problems or break-down in the internet system).

Instagram or Facebook does not support the Game in any form, they have not ordered the Game and Instagram or Facebook do not operate it.

Data processing. The personal data (name, email address) given by the Winner will be processed by the Organiser for the purpose of sending the Prize. The Organiser only stores these data until the end of the Game and use of the Prize. The legal basis for data processing is the participant's consent pursuant to Article 6 paragraph (1) a) of the 2016/679 regulation of European Parliament and Council (GDPR). Consent may be withdrawn at any time by sending an email to <u>dpo@sziget.hu</u>. Such withdrawal does not affect the lawfulness of processing based on consent before its withdrawal.

Pursuant to the GDPR, during the data processing, the participant may request access to the personal data and may request information about data processing (which will be provided by Organiser within no more than 1 month), may request rectification or erasure of personal data or the restriction of data processing.
