

ANNEX 2

Technical building specifications related to the Site

The purpose of this Annex is to summarise the most important construction, engineering and technical requirements that Sziget Kulturális Menedzser Iroda Zrt. (“**Sziget**”) expects from third parties (in particular sponsors, caterers or other persons entitled to operate commercial units, hereinafter referred to as “**Partner**”) contracted to organise certain venues (hereinafter each a “**Venue**”, together “**Venues**”) of Sziget’ events (hereinafter each a “**Event**”, together “**Events**”). This Annex summarises the relevant applicable rules and defines the scope of the persons authorized to control the Venue. Notwithstanding the provisions of this Annex, the Partner shall comply with all applicable laws and regulatory requirements and other rules implemented by Sziget.

The Partner shall comply fully with all the provisions of this Annex in the course of its activities, except as otherwise provided herein, and shall also comply with them in relation to all its subcontractors, contractors, contractors, operators, suppliers and all persons performing activities for it under any title whatsoever, and their subcontractors and contractors (hereinafter collectively referred to as “**Contributor**”).

It is the responsibility of the Partner to comply with all applicable building and technical regulations and standards and to monitor their changes. The Partner shall comply with all applicable legal regulations and standards during its on-site activities and shall also comply with them with its Intermediaries. The Partner further acknowledges that the authorities are entitled to stipulate specific construction, technical and other conditions during the approval of the Event, which the Partner shall take into account and observe during its on-site activities and shall comply with them with its Intermediaries. The Partner shall also be obliged to comply with the provisions of the applicable legislation on the protection of the townscape in relation to its activities and to ensure that its Intermediaries comply with such legislation.

However, Sziget would like to draw your attention to the fact that the information on the applicable legislation in this Annex has been compiled to the best of Sziget’s knowledge, but is intended solely to assist the Partner in its activities and should not be considered as a complete and up-to-date description of the applicable legislation.

Compliance with the regulations set by Sziget, as well as the applicable rules and legal provisions, may be monitored by Sziget as the organizer of the Event, by its appointed consultant, and by the competent authority specified in the legal provisions. With regard to these regulations, rules and legislation, Sziget shall be entitled to check the relevant requirements at its Events, to draw the Partner’s attention to the necessary corrections, to prohibit, suspend or stop construction/demolition work and to prohibit the operation of the facility. All this applies to both the Partner and its Contributors, but Sziget shall require the Partner as the contracted partner to comply with the construction, documentation and other provisions, and the Partner shall duly inform any third party involved as a Contributor in the

performance of the work and shall require the Partner to comply with these regulations. Any infringements/breaches of contract by the Partner's Contributors and the consequences thereof shall be dealt with jointly and severally by Sziget in respect of the Partner and the Intermediary who has committed the actual infringement/breach of contract. The Partner shall be fully and directly liable for any damage caused to Sziget or Sziget's Contributor by Partner or its Contributor at the Event or in connection therewith, in particular for damage resulting from breaches of the rules of conduct and the rules of construction/demolition/operation of the facility. In addition to the above, the Partner shall assume full indemnity and responsibility towards the Island in respect of its Intermediaries.

Pursuant to Government Decree 23/2011 (III. 8.) on making the operation of music and dance events safer (hereinafter the Decree), an Integrated Emergency Response and Security Plan is prepared for the Event, which is a confidential document that is not accessible to any Partner. The instructions contained in the Integrated Emergency Response and Safety Plan shall be complied with by all parties involved in the construction, and any regulations and stipulations of the authorities in accordance with the Decree, as well as those imposed by the control authorities during the Event, shall be fully complied with during the operation of the Event, even if they are notified during the Event.

1. Documents to be submitted in advance by the Partner and approved by Sziget

- Scaled site plan (top view drawing of the unit and the total gross occupied area).
- In the case of buildings, special structures, works of art, structures with awning structures, scaffolding structures, design documentation or equivalent technical documentation, credible evidence of the compliance of the fire protection, combustibility, smoke generating capacity and flame drip properties of the materials of the structures as required by the National Fire Safety Regulations of the Ministry of the Interior Decree 54/2014 (XII. 5.) on the publication of the National Fire Safety Regulations (hereinafter: OTSZ) and the related technical guidelines, and, if necessary, the presentation of safety lighting systems.
- The lightning protection design and the adequacy of electrical installations of structures, scaffolding, awnings and other temporary stands and display installations must comply with the requirements of the Directive on electrical installations, lightning protection and protection against electrostatic charging TvMI 7.6:2024.02.01.

- A brief description of the activity or activity related to the Venue.
- Electricity, water, sewerage and other technical needs during the Event (the costs of installation and operation of which are borne by the Partner).
- Name(s), e-mail and mobile phone contact details of the responsible natural person(s), start and end of construction, handover date, start and end of demolition, on the part of

the partner and, if different, the contractor/operator/third party carrying out the restoration.

- Whether they intend to carry out activities involving a fire hazard, their documentation required by law (in particular with regard to the requirements set out in the OTSZ and the related Technical Guidelines for Fire Protection (hereinafter: TvMI) and the provisions of Government Decree No. 173/2011 (VIII. 24)), name and contact details of the pyrotechnician.
- In case of installation of the show equipment specified in ITM Decree 24/2020 (VII.3.) (tents, stages, covers, show games, etc.) in the area of any Sziget event, the documentation of the equipment in question shall be as specified in the Decree, in particular the valid certificate of conformity issued by an accredited institute in Hungary, the certified operation logbook and the construction-installation description of the Venue.
- In case of the installation of any equipment or tent or an equivalent superstructure, the floorspace of which exceeds 50 sqm or the interior height of which exceeds 5 m, the statement on the wind capacity of such equipment, tent or superstructure.

The Partner shall submit the request for the necessary technical equipment by e-mail and the documents indicated above to Sziget by photocopy or e-mail five to six weeks prior to the opening day of the Event, as follows, with the proviso that in the case of a contractual relationship of several years, Sziget shall send the Partner the relevant dates in writing each year:

For the MBH Bank Gourmet Festival at the latest:	1 April, 2026
For the Children's Island at the latest:	22 April, 2026
For Sziget Festival at the latest:	1 June, 2026

Technical documentation may be submitted at a later date only if agreed, but in any case must be received 4 (four) weeks before the opening day of the event. If technical equipment is ordered after the deadline, Sziget cannot guarantee the provision of the equipment.

At all Sziget events, only structures and equipment that fully comply with the current legal and technical requirements, in particular:

- the provisions of the ITM Decree 24/2020 (VII. 3.),
- for temporary structures, tents and stage covers, the requirements of the tent standard MSZ EN 13782:2015,
- for structures for spectator facilities, dismantlable temporary stands, the requirements of MSZ EN 13200,
- the requirements of the MSZ 2364 series of standards IEC 60364-7-711 for electrical equipment for exhibitions, demonstrations and stands,
- for low voltage electrical equipment in mobile or transportable units, the requirements of MSZ HD 60364-7-717:2010,
- for lifting and load-bearing structures for stages and other performing arts facilities, the requirements of standard MSZ EN 17206:2020,

- for outdoor lighting installations, the requirements of MSZ HD 60364-7-714:2013.
- in general, the applicable Technical Guidelines on Fire Safety for Outdoor Mass Events.
- ISO EN 13200-6:2021 Spectator seating - Part 6: Dismountable grandstands
- ISO EN 13200-4:2023 Equipment for public spaces - Part 4: Seating. Product characteristics (English)

The Partner must present, prior to the Event, the necessary documents certifying the regularity of the equipment or structure it intends to install. The lightning protection and electrical

standard inspection report must be presented, or credible proof must be provided that any deficiencies found in the report have been rectified. Without the official permits for the devices (structures) subject to building permits or notification, the installation may not be started. The operation of structures and equipment is prohibited without the submission of the responsible contractor's declaration.

Sziget shall be obliged to inform the responsible natural persons referred to in the present point above orally, for reasons of force majeure or other circumstances, via the mobile telephone contact details set out above, and to confirm this in writing without delay by SMS or e-mail message with a digest. The Partner shall be responsible for providing the mobile telephone and e-mail contact details, and Sziget shall not be held liable for any attempt to duly notify the Partner in accordance with this paragraph, irrespective of its success.

2. Documentation to be kept at the Venue by the Partner and presented if necessary

- Fire and occupational safety, electrical safety codes, training logs (with topics);
- In the case of structures covered by ITM Decree 24/2020 (3 July 2020), a valid certificate of conformity, a certified logbook and a Venue-specific construction-installation specification;
- The Partner shall be in possession of the work safety risk assessment related to the Events and the work activities on the Events. The contents and the elaboration of the Partner's work safety risk assessment shall equal to the work safety risk assessment shared by Sziget;
- Possible (stage, bleachers, roof) technical certificates, flame arresting (flame retardant), conformity certificates;
- MSZ-EN 2364 (old MSZ 1600 and 172/1) declaration, and a single line /full scale/ drawing of the Venue;
- Contact protection, electrical standardisation inspection report, lightning protection inspection report;
- In the case of water construction, the report of the inspection, in the case of wastewater transport, the wastewater transport contract (if the transport is not carried out by Sziget);
- The originals of the documents indicated must be kept on the premises from the opening day of the Event for the entire duration of the Event and must be presented by the Partner or the actual operator of the Venue to the competent authorities during any checks;
- Construction of scaffold structures, tarpaulin structures, certification of compliance with the OTSZ and the following standards:
 - ISO EN 13782:2015 Temporary structures. Tents. Safety
 - ISO EN 17115:2019 Entertainment technology products. Technical requirements for the design and manufacture of aluminium and steel lattice supports

- ISO EN 17206:2020 Entertainment technology products. Machinery for stages and other performing arts installations. Safety requirements and inspection

3. Equipment, designs and procedures required for operation

- A valid fire extinguisher of the appropriate type and number;
- If gas cylinders are used, only explosion-proof design with safety relief valve is possible, maximum 1 to 1 per firing or heating appliance. The storage of spare cylinders in the Event area is not permitted, not even in a private vehicle. Partners willing to use gas cylinder must in advance inform Sziget on the place of the usage, the name and telephone contact information of the user and the quantity of the gas cylinder(s) will be used;
- Electrical fittings with IP rating appropriate for the installation;
- The onward routing of electrical cables from the junction box to the Event must be provided by the event Partners in a technically secure manner (with the best possible protection, e.g. cable grating, cable tunnel, rubber blanket covering);
- At all Sziget Events, the Partner shall keep a record of its electrical equipment in accordance with clause 10;
- The electrical equipment used must comply with the following legislation and have the qualifications specified therein:
 - MSZ 2364
 - Act 93 of 1993 on Occupational Safety and Health
 - Decree No 5/1993 (XII. 26.) of the Ministry of the Interior
 - ITM Decree 34/2021 (26.VII.)
 - OTSZ and related Technical Guidelines for Fire Safety

4. Use of sound equipment

If the Partner wishes to use sound equipment at the Sziget Festival, the Partner shall consult with the Sziget in advance as follows:

If the power of the sound equipment (max. "two occupants") does not exceed 2x100 W, the Island will only check the conformity of the equipment with the declared and real power.

If the power of the equipment to be used exceeds 2x100 W musical power, the Partner shall use an "electronic sound pressure limiting device" in its unit, which shall in any case be installed by the Island on the premises at the Partner's expense. In addition, the Partner shall provide Sziget with a complete list of the sound equipment to be used, in writing, 4 weeks before the Event in question (in accordance with the deadlines set out in point 1 of the Regulations). During operation, the "electronic sound pressure limiting device" controls the musical performance on a site-specific basis (thus reducing the noise pollution of the environment of the Event in question). Circumvention or circumvention of this device shall be

considered a serious breach of these Regulations, as a consequence of which Sziget may prohibit the provision of music at the venue in question for the entire duration of the Event.

The equipment is the financial responsibility of the Partner - the Partner is obliged to take over the equipment on the basis of a handover report, to use it as intended, to be responsible for the integrity and functionality of the equipment and to compensate for any damage (damage, leaking, breakage, etc.).

When using any sound equipment, sounds below 100 Hz between 23.00 and 8.00 hours must be reduced by 6 dB.

During the Events, the Partner is obliged to comply with the instructions of the sound technicians employed by Sziget and to respect the predetermined sound pressure levels in all circumstances.

5. Pre-opening check

Technical staff must be requested to come to the Venue before the public is admitted:

- for the siting of individual buildings
- for devices subject to technical examination, notification or authorisation
- if the Partner has requested or intends to carry out a fire risk activity, including the starting of a fire
- protection protocol, in the case of a device subject to lightning protection

In the event of a serious risk of accident or infringement, the activity may be restricted or prohibited altogether until it is repaired and re-inspected.

6. Other provisions

Sziget shall inform the Partner in advance of the earliest possible date for commencing construction and dismantling at the Event site, as well as the latest possible date for completing such work.

Construction may only commence with the knowledge of the Technical Department and, in case of brand partnership Partners, the Technical Department and the Partnership Department, and in case of commercial Partners, the Technical Department and the Commercial Department, in each case after on-site consultation, in full compliance with all applicable Hungarian laws, regulations and technical requirements.

Prior to the commencement of construction work, the parties shall conduct a joint site inspection, during which they shall record the current condition of the Venue in a protocol, with particular regard to green areas, existing built elements, utilities, pavements, and other

facilities. The protocol shall serve as the basic document for the handover of the Venue and shall be used as a basis for comparison when assessing the condition of the Venue area during the joint inspection carried out upon its return after demolition. The Partner shall return the Venue area in accordance with the condition recorded in the protocol, taking into account the inevitable wear and tear resulting from its intended use.

During the construction and operation, the following persons may control the Partner and/or its Contractor on behalf of the Island and may prohibit the activity.

In the event of imminent risk of accident or flagrant breach of law or breach of contract between Sziget and the Partner:

- Horváth Tibor Technical Consultant
- Ferenc Attila Commercial Manager
- Koppány Gyenge consultant
- The Head of the Operational Management Centre, in charge of governance
- Sziget's accredited advisors (e.g. safety advisors for occupational health and safety, fire and disaster management) and all competent authorities and specialised bodies

7. Information and rules on implementation

If the device to be installed is an installed tent or equivalent structure with a floor area of less than 50 m² and a ceiling height of less than 5 m, the person responsible for its installation must make a written declaration. The declaration shall also contain that (i) it has been installed in a manner appropriate to the statics of the device and the expected wind load, that (ii) it has been secured to the ground in the area in accordance with the conditions of the site, with a sufficient number and quantity of stakes or with an appropriate amount of weighting. The anchorage shall take into account the best quality of anchorage that can be expected, both in terms of the number of anchorage points and the quality of materials used.

It is forbidden to attach to any landmarks in the area. For tents or equivalent structures with a floor area of more than 50 m² or a ceiling height of more than 3 m, the installation is subject to a valid inspection report. It is **STRICTLY FORBIDDEN** to drill, dig or place any equipment at a depth of more than 30 cm, except in precisely designated and agreed locations, in order to protect the infrastructure. The Partner shall be liable for any resulting damage. For park and environmental reasons, damage to lawns, trees, bushes and paths is prohibited on the Sziget's Event sites. The full cost of restoration will be invoiced, and Sziget may hand over the Partner's and/or the Associate's details to the competent authorities in the event of a complaint to the authorities.

For the construction of tents with a floor area of more than 50m², the procedure shall be in accordance with the Government Decree 281/2024. (XI.30.) on procedures and inspections of building and building supervision authorities and on the service of building authorities. The

same regulations apply to the construction of stages, roofs, bleachers and other temporary structures.

In the case of any Sziget Event, the Partner shall be fully legally and financially liable for the preparation, during the operation and dismantling of the Venue, in particular for compliance with fire, environmental, labour and occupational safety regulations and all mandatory legal provisions.

Further to requirements related to healthy and safe work activities provided by work safety laws, the Partner shall also comply with the requirements determined by Sziget in relation to the healthy and safe work activities. The respective documentation (description and plot) will be shared by Sziget to the Partner, for information purposes and acknowledgement, at least 2 (two) weeks prior to the commencement of the onsite work.

A technical expert from the ÉMI-TüV-SÜD will inspect the area 72 (seventy two) hours before the official opening of the Event and will record his/her observations in a report, which will be binding for all participants. In the event of any deficiencies, the Partner shall immediately take care of the necessary repairs and shall carry them out no later than the official opening of the Event, otherwise the Partner shall not be entitled to open the unit in question.

8. Construction-finishing declaration

The Partner, being aware of its criminal liability, declares that the equipment to be set up at the Event and its related works (installation, commissioning, operation and demolition) comply in all respects with the applicable Hungarian legislation and technical specifications, and that it has the documentation required by the applicable legislation. The installed device complies in all respects with the requirements of ITM Decree 24/2020 (3 July 2020), has a valid certificate of conformity, a certified operating logbook, the site construction-installation specification and is installed in accordance with the requirements of the latter. The original, certified, valid documentation of the above-mentioned device must be available at the Venue at all times during the period of operation. Partner is familiar with the provisions of the relevant legislation, takes the provisions of the legislation into account in the design of the construction and operation, and complies with all the requirements of the legislation.

The Partner warrants that during the installation works, the construction process and the execution of the construction, all the equipment has been installed in accordance with the ground conditions and the technical design documentation (e.g. the required number of stakes or the appropriate amount of weighting). The Partner shall specify in the visual design and conceptual design the wind load capacity of the structure according to the design documentation and the lowering wind speed for stages and covers. Partner warrants that during the installation, the structure will be installed in a structurally sound manner in all

respects, that the material qualities and construction methods used will comply with Hungarian legislation and that the most prudent workmanship can be expected.

9. Car transport and parking

As a general rule, no vehicles of the Partners and/or its Contributors are allowed to enter/park in the Event/Site. During the building and demolition and the Event, only vehicles with a valid driving licence may drive and park in the Event area to the extent and in a manner as determined by Sziget in advance. A permit must be applied for in advance and will be assessed by the Island and issued only in the most urgent cases.

The rules of the Highway Code apply in the Event area. In order to protect the environment, only the designated traffic routes may be used for motor vehicle traffic at the Event; all other areas, e.g. grassed areas, are off limits. When entering into the Event site upon prior consent, Partner and/or its Contributor is obliged to drive safely and carefully with the maximum speed of 10 km/h, taking into consideration the actual weather conditions (dryness, dust, rain, mud) and to avoid blocking the traffic routes, the fire department access routes and the areas required for the safe and convenient operation of the Event.

In the event of construction, the Partner and/or its Contributor shall remove their vehicles before the opening of the Event, and in the event of demolition, in order to avoid congestion and accidents, vehicles may only enter the Event area after the visitors have left. Demolition work that is carried out in an area away from visitors or that does not threaten the physical safety of visitors may be carried out from an earlier time by the Partner and/or the Intermediary with the express prior authorisation of the Sziget.

The Partner and/or the Contributor shall indicate the name and mobile phone number of the driver of the vehicle entering the Event area at all times (including during construction and demolition).

During the Event (including during construction and demolition), owners/operators of vehicles entering or parking without permission will be asked to leave the area by security.

In the event that vehicles operated by the Partner and/or its Contributor are present in the Event area during the Event (including during the construction and demolition period) in excess of the limits authorised by Sziget or in an irregular manner, interfering with the work of the Organiser, Sziget shall be entitled to have these vehicles removed immediately at the expense of the Partner, with immediate notification to the Partner and simultaneous recording of the Event. This provision shall be applicable during the whole period of the Event, including the period of building and demolition.

The Parties agree to accept the minutes taken by Sziget as sufficiently conclusive and authentic as regards the condition of the vehicle at the time of removal.

Sziget shall park the removed vehicle in the designated parking area at the location indicated to the Partner in writing in advance, from where it shall be released to the Partner and/or its Contributor after reimbursement of the costs incurred and proof of due entitlement. The Parties exclude the Sziget's liability for any damage that may occur in connection with the storage of the vehicle on the site or the late arrival of the Partner and/or its Contributor.

In case of violation of the above rules, Sziget may impose a partial (for a specific Event/single Events) or total (for all Events organised by Sziget) ban for a fixed period (until the end of the Event or for a fixed period longer than that) on any member of the Partner's and/or the Contributor's work organisation. After the expiry of the ban, Sziget shall be entitled to impose specific conditions on the right to attend Events.

Sziget shall inform Partner on the detailed rules of the eventual drive-in to and traffic at the territory of Sziget Festival to be held at Hajógyári-sziget and on the further consequences of any breach of these rules, in addition to those written above, no later than 20 (twenty) days prior to the first day of Sziget Festival, which the Partner shall also make available to its Contributors.

10. Rules on operation and management

The Partner agrees to cooperate with the Island in all respects to enforce the provisions of the Integrated Emergency Response and Security Plan.

The Partner shall ensure that only persons who have received fire and safety training are employed at the Event and carry out any activities. The Partner shall ensure that the fire safety training is provided by a person with the professional qualification specified in the Decree of the Ministry of the Interior No. 9/2015 (25.III.). One must be able to provide credible evidence of both the fire and safety training and of the entitlement to such training at any time on the spot.

Only LPG bottles with safety blow-off valves supplied and distributed by the contractor contracted by Sziget may be used in the Events area. It is prohibited to bring LPG cylinders into the Event area, including the starter kit. A permit to bring in LPG cylinders may not be issued or ignored by the security service at the entrance.

In accordance with the policies applied by Sziget in relation to its Events, drones may be brought into the area of any Event in full compliance with the legislation in force and only upon the prior written permission of Sziget. Furthermore, in the absence of the foregoing, it is prohibited to fly a drone into the area of any Event from a location outside the area of the Event concerned. In such cases, Sziget will initiate proceedings against the person flying the drone with the competent authorities. At the Gourmet Festival and the Sziget Festival, ad hoc

airspace will be used, the ad hoc use of which, subject to prior authorisation, shall be governed by the relevant conditions of use.

11. Use and listing of electrical equipment

The Partner warrants that the electrical equipment installed at the Venue and the related works (installation, commissioning and operation) comply in all respects with the applicable Hungarian legislation in force and in force at the time, and that they have the documentation required by the applicable legislation (e.g. contact protection measurement and the report certifying it).

At all Sziget Events, the Partner shall keep a record of its electrical equipment, which shall include the electrical equipment installed.

When operating or installing electrical equipment, the authorisation to carry out the activity must be taken into account. The utmost care must be taken when operating or putting into service, depending on the equipment:

- anyone (computer, radio, charger, fridge)
- trained staff (heat generator, fryer, boiler, coffee machine, sound equipment)
- qualified trained personnel (heat generators over 10kW, lighting equipment)
- qualified, trained and type-tested personnel (generators over 10kW, complex electrical equipment)

Register tab - Device list contains the following data:

Comments:

The first number of the IP protection is for the electrical contact and the second number for the water protection. For Events, the minimum IP rating is IP44. 1mm of conductive material is not touchable, e.g. wire and is protected against splashing water.

If the electrical equipment is factory made, points 1 to 7 are given. If the equipment is home-made, it can only be certified by a qualified technician with an OKJ

qualification. Simple electrical equipment is only certified if necessary (laptop, telephone charger, fixed lighting with plastic housing).

For the given location, the Partner, as a partner contracting with Sziget, assumes direct responsibility and shall be liable for accepting the above as binding both for itself and for all its Contributors it wishes to involve in the performance, and for complying fully with them, both itself and its Contributors, and for taking all reasonable and necessary steps to enforce them in relation to its Contributors.

The safety of life and property is always the most important factor at all Events organised by Sziget Kulturális Menedzser Iroda Zrt. The present Technical Regulations and the work of the professional staff on site serve this purpose in a complex and complicated legal/regulatory environment. Should there be any questions about the above or beyond, the Sziget team will assist you to the best of our ability and ability, as our common goal is to ensure the safe and secure execution of the Event in the smoothest possible way.

12. Recommendations on environment and climate protection

The Partner is obliged to familiarize itself with the Sustainability Strategy of the Sziget Festival for 2026 (https://szigetfestival.com/wp-content/uploads/2024/04/Sustainability-policy-Sziget-2026_en.pdf) During the Sziget Festival, the Partner shall endeavour to cooperate in the implementation of the strategic objectives.

Sziget recommends the use of souvenirs made of OEKO-TEX 100 Standard certified textiles for its partners.

The Partner commits to prioritise sustainable and climate-friendly solutions in its on-site activities, to strive for the use of natural materials, to focus on energy saving and to procure materials with short transport distances.

13. Mandatory rules on environmental and climate protection

The Partner shall not be entitled to distribute single-use plastic souvenirs at the Events without Sziget's prior permission, and the distribution of plastic wrapped souvenirs at the Events is also prohibited.

The Partner shall be obliged to fully separate all waste at the Event Venue. The Partner is liable for avoiding waste production and for the selective collection of waste produced. It is strictly forbidden to leave waste on the Event site. The Partner is liable for properly preparing waste for transport and for delivering it to the appropriate collection point for each type of waste. If the Partner leaves waste outside the designated collection point for each type of waste, it shall be obliged to pay a penalty of HUF 1,000,000, i.e. one million Hungarian forints. Detailed regulations on waste management are contained in the waste management regulations implemented by Sziget, which Sziget shall publish no later than 90 (ninety) days prior to the start date of the Sziget Festival.

Partner may only provide its employees with a replica cup or a BPA-free reusable canteen, the use of 0.5 litre PET bottles is prohibited.
