

## **REVOLUT SPRING SALE PROMOTIONAL AND PRIZE GAME RULES OF PARTICIPATION**

This present Rules of Participation (hereinafter “**Rules**”) set forth the terms of participation in the promotion (hereinafter “**Promotion**”) and prize game (hereinafter “**Prize Game**”) to be held under the name “**Revolut Spring Sale**” (the Promotion and Prize Game together hereinafter “**Game**”) in connection with Sziget Festival 2025.

**The organizer of the Game.** The Game is organized by the organizer of **Sziget Festival 2025** (hereinafter “**Event**”), **Sziget Kulturális Menedzser Iroda Zártkörűen Működő Részvénytársaság** (Hajógyári sziget, hrsz. 23796/58, 1033 Budapest, Hungary, Reg. No.: Cg. 01-09-263756, tax number: 10837410-2-41, hereinafter “**Organiser**”).

**Term of the Game.** The Game shall be held during the online ticket sales for the Event, between 20:00, May 28, 2025, and 20:00, June 1, 2025 (CET). The Organiser reserves the right to change the term of the Game.

**Description of the Game.** During the term of the Promotion, the purchase price of the purchased products can be only paid by Revolut Pay payment solution. Such successfully conducted transaction (i.e. during which the payment transaction is fully completed), with no regard to the type and quantity of the products purchased within the frames of the transaction shall qualify one promotional purchase (hereinafter “**Promotional Purchase**”).

During the Promotion the 3 (three) days and 6 (six) days passes for the Event can be purchased for a discounted price. The discount is not applicable for other products.

After each successful Promotional Purchase an online scratch card will be displayed on the webpage, by scratching of which, each person who has purchased products within the frames of the Promotional Purchase may participate in the Prize and will be entitled to a Revolut Spring Sale guaranteed promotional gift (hereinafter each a “**Guaranteed Promotional Gift**”, together “**Guaranteed Promotional Gifts**”) and furthermore, may win a prize (hereinafter each a “**Prize**”, together “**Prizes**”). One Promotional Purchase entitles to one entry into the Prize Game.

**Participants of the Game.** The natural persons conducting a Promotional Purchase during the term of the Game shall participate automatically in the Promotion. Each natural person who, after conducting the successful Promotional Purchase, scratches the online scratch card on the webpage may participate in the Prize Game (hereinafter each a “**Player**”, together “**Players**”).

**The Guaranteed Promotional Gift.** The Guaranteed Promotional Gift shall be 1 (one) Merch Coupon with the value of HUF 5,000 to which each Player will be entitled by the participation on the Prize Game, i.e. by scratching the online scratch card displayed on the webpage after the successful Promotional Purchase. The Merch Coupon maybe used solely for the purchase of the 2025 Lineup T-Shirt, during the term of the Event at the merch store located at the venue of the Event (cannot be used for online purchase).

**The Prizes.** The following Prizes can be won in the Prize Game:

- Full Normal Festival Pass (5 pieces)
- 3 Days Normal Pass (5 pieces)
- VIP Upgrade for 6 days (5 pieces)
- VIP Upgrade for 1 day (10 pieces)
- Revolut VIP 6-day Access (valid for the Revolut Stage for 6 days) (10 pieces)
- Moving-in ticket (10 pieces)
- Sziget Ville Premium Ticket (10 pieces)
- Boat Party Ticket for 2 persons (10 pieces)
- Castle Party ticket for 2 (5 pieces)
- Backstage Tour & VIP Upgrade for 2 for 6 days (1 piece)
- Siesta Camping Coupon 20% off (can be used only for the purchase of Siesta Camping ticket and solely at Organiser's webshop at [www.szigetfestival.com](http://www.szigetfestival.com)) (500 pieces)

**Conducting the Prize Game.** During the term of the Game, Players can buy any product for the Event from the Organiser's webshop at [www.szigetfestival.com](http://www.szigetfestival.com) within the frames of a Promotional Purchase and scratch off the online scratch card that appears on the website after successful Promotional Purchase. All Players are entitled to the Guaranteed Promotional Gift. The Prizes will be distributed randomly among the Players. Only the winning Players (hereinafter each a “**Winner**”, together “**Winners**”) will receive Prizes.

**Delivery of the Guaranteed Promotional Gifts and the Prizes.** The Players will be notified on the Guaranteed Promotional Gift by Organiser via electronic mail to the email address used for the Promotional Purchase and simultaneously therewith, the coupon will also be sent. The Winners will be notified on the Prize by Organiser by sending the voucher/coupon for the use of the Prize simultaneously with the notification on the Guaranteed Promotional Prize. The Winner of the Backstage Tour & VIP Upgrade for 2 for 6 days will be contacted by Organiser via electronic mail in connection with the use of the Prize. The Guaranteed Promotional Gifts and Prizes which are available at the Event venue or other locations related to the Event and during the term of the Event, may only be used only in case of attending at the Event, failing which the Guaranteed Promotional Gift and such Prizes cannot be used and the Player shall not be entitled to any consideration. The Backstage Tour is non-transferable.

The Guaranteed Promotional Gift and the Prize cannot be exchanged for money. Neither the Player/Winner, nor others are entitled to demand from the Organiser to exchange the Guaranteed Promotional Gift and/or the Prize to money or to any other gift. The Organiser does not provide any other gifts or prizes in the Game other than the Guaranteed Promotional Gifts and Prizes. No additional gift will be provided and no additional Winner will be selected if the Player loses his or her right to receive the Guaranteed Promotional Gift or the Winner loses his or her right to receive the Prize or does not fulfil his or her obligation in the given term to get the Guaranteed Promotional Gift /Prize, or he or she refuses to get the Guaranteed Promotional Gift/Prize.

Each Guaranteed Promotional Gift and Prize will be delivered only on 1 (one) occasion. By delivering the Guaranteed Promotional Gifts and Prizes, the Organiser verifies the Players/Winners only on the basis of the e-mail address provided for the Promotional Purchase. The Organiser expressly excludes its liability connected with the eventual abuses related to the receipt and the use of the Guaranteed Promotional Gifts and Prizes.

**Legal Characteristics of the Game.** The Game shall be considered as a business promotion in respect of the Guaranteed Promotional Gift and shall be considered as a prize game not classified as a gift draw in respect of the Prize. Organiser shall pay all taxes and contributions after the Prizes.

**General provisions.** The Game shall be held pursuant to these Rules. Participants shall accept the rules related to the Promotion as binding by conducting the Promotional Purchase. The Players shall accept the rules related to the Prize Game by scratching the online scratch card displayed on the webpage after conducting the successful Promotional Purchase. The Players are entitled to refuse to take receipt of the Guaranteed Promotional Gift and the Winners are entitled to refuse to take receipt of the Prize.

**Liability matters.** If there is abuse or any suspicion of abuse during the time of the Game, the Organiser reserves the right to suspend or to terminate the Game or to exclude the offender from the Game. In such a case, the Organiser excludes its all liability.

Guaranteed Promotional Gifts and Prizes can only be used on 1 (one) occasion. It shall be the sole obligation and responsibility of the Players/Winners to safeguard the coupon and voucher diligently, in a way to prohibit access by unauthorized persons. Organiser excludes its liability or all and any misuse.

The Players bear all consequences of giving incorrect personal data or if their mailboxes cannot receive letters. Organiser does not check the correctness of the aforementioned personal data. In this regard the Players exclusively bear all responsibility and all legal and financial consequences.

Organiser excludes any liability for any demand for compensation or indemnification or for any cost, damage, loss incurred by the Players as a result of participating in the Game. By participating in the Game, the Player expressly waives his or her right to have any claim against Organiser or any other third parties related to the conducting of the Game, the Guaranteed Promotional Gift/Guaranteed Promotional Gifts, the Prize/Prizes, the Player/Players or the Winner/Winners.

Organiser excludes its liability for any copyright infringement.

Organiser shall not bear any liability if the webpage that contains these Rules periodically cannot be found due to technical reasons during the term of the Game. Organiser shall not be liable for problems with the webpage and for their consequences beyond its control (for example technical problems or break-down in the internet system).

**Data processing.** The email address used by the participants in the Prize Game for the Promotional Purchase will be processed by Organiser for the purpose of sending notification on the Guaranteed Promotional Gift/Prize, making possible the use of the Guaranteed Promotional Gift/Prize, and keeping contact with the Players. Organiser only stores these data until the end of the Event. The legal basis for data processing is the participant's consent pursuant to Article 6 paragraph (1) a) of the 2016/679 regulation of European Parliament and Council (GDPR). Consent may be withdrawn at any time by sending an email to [dpo@sziget.hu](mailto:dpo@sziget.hu). Such withdrawal does not affect the lawfulness of processing based on consent before its withdrawal.

Organiser informs the Players that beyond the arrangement of the Game, the email address used for the Promotional Purchase is also processed for other purposes, for which the applicable privacy notice is available here: <https://szigetfestival.com/en/policy-gctc#!/c141/privacy-policies> (*Privacy policy concerning purchases for festivals organised by Sziget Zrt.*).

During the Backstage Tour, the Warm-up Party and the Boat Party, the photographers of Organiser will take professional photo which will be handed over to the entitled person. Organiser hereby informs you that the photo may also be used by Organiser for marketing purposes with an eye to those written in Section III.4.3. of General Terms and Conditions of Organiser (available here: <https://szigetfestival.com/en/policy-gctc#!/c140/general-contract-terms-and-conditions-rules-for-participation>) and the related data processing information (Privacy Policy concerning participation at Sziget Festival) (<https://szigetfestival.com/en/policy-gctc#!/c141/privacy-policies>). Organiser processes the photos as recordings (hereinafter “**Recordings**”) and the data therein for the purpose of creating from them (i.e. from the Recordings) audiovisual material aiming to present, publicize, and promote the use thereof the individual events and the events in total, as well as the events, other services of, and itself the Organiser, furthermore, aiming at information and documentary purposes (together “**Films**”). The personal data contained in the Recordings are only processed in the context of making and publishing the Films as specified in the relevant data privacy policy. The Recordings, and, therefore, also the personal data included therein is processed by Organiser for an indefinite period, however, acts as described above during the exploitation thereof. The Recordings, the Films, and the creations, creatives as a result of their exploitation are at the same time copyrighted works, with regards to their protection, Organiser may not exercise deletion without the consent of the author but, upon the request of the data subject, in connection with the exploitation, the right of protest of the data subject can be exercise within the frameworks of technics and reasonable realization (for which, please, contact us on the [dpo@sziget.hu](mailto:dpo@sziget.hu) address).

Pursuant to the GDPR, during the data processing, the participant may request access to the personal data and may request information about data processing (which will be provided by Organiser within no more than 1 month), may request rectification or erasure of personal data or the restriction of data processing.
