

## **Sziget Festival Day Ticket Pre-registration Terms and Conditions** (“Terms and Conditions”)

**Sziget Cultural Management Limited** (registered seat: 1033 Budapest, Hajógyári sziget 23796/58., company registration number: Cg. 01-10-049598, hereinafter “**Sziget**”) hereby offers day ticket pre-registration (hereinafter “**Day Ticket Pre-registration**”) for the **2026 Sziget Festival** (hereinafter “**Event**”), which allows persons over 16 (sixteen) years of age completing the pre-registration (hereinafter “**Participants**”) to purchase **Normal Day Ticket, VIP Day Ticket, Sky VIP Day Ticket and upgrades to Day Tickets** (hereinafter collectively “**Day Ticket**” or “**Day Tickets**”) for the Event during the first sale of Day Tickets (hereinafter “**Day Ticket First Sale**”) at the best price made available for Day Tickets by Sziget (hereinafter “**Day Ticket Best Price**”).

Pre-registration can be completed by providing an email address during the Pre-registration period. By completing the Day Ticket Pre-registration, the Participants will also subscribe to the Event’s newsletter. Participants accept these Terms and Conditions, the privacy policy related to the Day Ticket Pre-registration and the privacy policy related to the Event’s newsletter by making such statement in the course of the Day Ticket Pre-registration.

Pre-registration does not create any obligation to purchase, but Day Tickets at the Day Ticket Best Price are only available to the Participants, i.e. the persons who have completed Day Ticket Pre-registration.

The Day Ticket Pre-registration period begins at 10:00 March 20, 2026 and ends at 20:00 March 23, 2026. Sziget shall be entitled to unilaterally modify, suspend or terminate the duration of the Day Ticket Pre-registration if justified by technical, security-related, commercial or other circumstances materially affecting its operation.

The Day Ticket First Sale shall begin at 10:00 March 24, 2026 and will last for 24 (twenty-four) hours on the dedicated webpage for the Day Ticket First Sale. During the Day Ticket First Sale, Sziget will verify Participants based on the email address provided during the Day Ticket Pre-Registration. The Day Ticket Best Price cannot be combined with any other discount. If there is high demand during the Day Ticket First Sale, the Participants may be queued.

Sziget excludes its liability for any damage, loss or disadvantage arising in connection with the Day Ticket Pre-registration, the Day Ticket First Sale or the purchase process where such damage, loss or disadvantage arises from any cause within the Participant’s sphere of interest, including in particular incorrect or inaccurate data provision, technical errors, delivery issues, internet connection failures, unauthorized access or abuse.

Sziget reserves the right to exclude from the Day Ticket Pre-registration and/or from the possibility of purchasing during the Day Ticket First Sale any Participant who breaches these Terms and Conditions, attempts to circumvent them, or otherwise engages in abusive conduct.

During the Day Ticket Pre-registration and the Day Ticket First Sale, Sziget’s relevant terms and conditions shall apply to any other issues.

Sziget reserves the right to unilaterally amend these Terms and Conditions. The amended Terms and Conditions shall be published by Sziget on the appropriate platforms.
