

PRIVACY POLICY
Addendum to the visitors' privacy policy
concerning the SZIGET Skateboard Halfpipe

The SZIGET Skateboard Halfpipe (hereinafter: "Program") is organized in connection with SZIGET Festival (hereinafter: "Festival") as per the terms of participation published. During the participation in the Program, we process further personal data in connection with the visitors participating the Program, which we process in accordance with the relevant effective legislation, especially Regulation 2016/679 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (hereinafter the "**GDPR**").

We hereby inform you on the details of the processing of your personal data and your corresponding rights.

The scope of processed data, the purpose, duration and legal basis of data processing in connection with the Program:

Purpose of data processing	Only such persons may participate the Program organised by Sziget Zrt. who comply with the terms of participation, observe the terms and instructions during the Program, take part in the Program in a manner not jeopardizing the safety of others. In order to ensure this, Sziget Zrt. make the participants declare thereof.

Legal basis of data processing	In connection with the participation in the Program, Sziget Zrt. handle the consents for the sake of clarifying liability in relation to self-caused injuries, acts as per Section 164 of Act C of 2012 on the Criminal Code, as well as in consideration of occurrent enforcement of civil law claims as per Section 6:22 of Act V of 2013 on the Civil Code, and protection against occurrent civil law claims of data subjects' claims, i.e. Sziget Zrt. handle the occurrent affected personal data with regard to its legitimate interest pursuant to Point f) of Article 6 (1) of the GDPR.
Duration of data processing	In case no issue occurs during the Program, in connection with the participation thereon, Sziget Zrt. destroy the data, the declarations related to the participation on the 8 th working day following the official end of the Festival. In case any issue occurs or there is a suspicion of any, Sziget Zrt. shall be entitled – even in lack of initiating any authority procedure – to decide that it shall respite the deletion, the term of which voluntary respite may not exceed 30 days. In the event of a legal proceeding, the data shall be handled until the final closing of the procedure.

DATA SECURITY

Sziget Zrt. shall ensure the security of the personal data and shall implement appropriate technical and organizational measures to ensure that the collected, stored and processed data are protected, in addition to preventing destruction, unauthorized use, and unauthorized alteration of the data. Sziget Zrt. shall furthermore notify third parties - to whom the data subject's information is transferred - that they are obligated to meet the data security requirements.

Sziget Zrt. shall ensure the prevention of unauthorized access to personal data, as well as the publication, transfer modification or erasure thereof.

Sziget Zrt. shall impose the aforementioned obligation onto its employees taking part in the data processing, as well as the data processors acting under the authority of Sziget Zrt.

THE RIGHTS AND LEGAL REMEDIES, COMPLAINTS OF DATA SUBJECTS

Pursuant to the GDPR, during the data processing, you may request access to the personal data and may request information about data processing (which shall be provided by Sziget Zrt. within no more than 1 month), may request rectification of personal data, erasure under certain conditions, or the restriction of data processing, and - when the legal basis for data processing is performance of a contract - you have the right to data portability. When the legal basis for data processing is legal interest, you have the right to object.

Personal data related to children and third persons

Persons under 18 may not participate the event.

Only the participants of the Program may lawfully make declarations in connection with their participation.
